

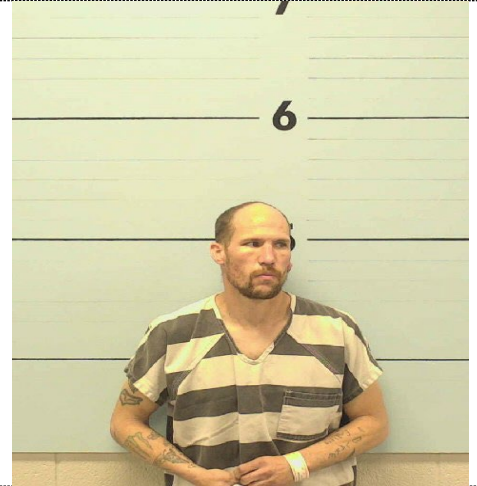

Details:

Beginning on 01/10/24 through 01/11/24, the Burke County Sheriff's Office Criminal Investigations/Narcotics Division, NC Department of Adult Corrections/Special Operations and Intelligence Unit, and United States Marshals Service/Carolinas Regional Fugitive Task Force conducted a joint operation to locate and arrest Felony Probation Absconders from NC DAC Burke County Probation/Parole.

During this operation, Natalie Anne Henson, formerly of 4921 Laurel Creek Street was found fleeing from a structure located on, or about, 6859 Rhoney Road in an attempt to evade law enforcement. Henson was taken into custody after a short foot chase and was found in possession of Methamphetamine, a Schedule II controlled substance. Henson had been evading apprehension since on or about 09/20/23. On 01/11/24 Victory Tyrone Coffey was taken into custody without incident at a residence, located at 1924 Wortman Street. Coffey had been evading apprehension since on or about 08/24/2023. Kenneth Blake Clark was apprehended at 3189 Barus Pond Loop and was arrested without incident. Clark had been evading apprehension since on or about 09/15/22. This operation was a multi-agency collaborative endeavor conducted in an effort to apprehend felony probation/parole absconders.
