

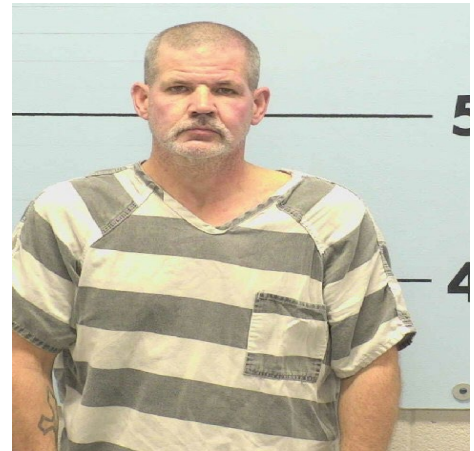

Details:

On January 26, 2024, Burke County Sheriff's Office Criminal Investigations/Narcotics Division and NC Department of Adult Corrections: Probation/Parole were conducting a joint operation incorporating undercover and conspicuous patrol actions in the Hildebran/Icard community, after numerous citizen complaints about illegal activities in the area. At approximately 10:00 a.m. officers/investigators saw Jon Bradley Williams operating a motor vehicle in the target area of the investigation. Investigators familiar with Williams knew he was operating a vehicle with a revoked license and was currently on active probation and officer(s) initiated a traffic stop. During the traffic stop, probation was contacted, and Williams was asked to exit the vehicle and a search was conducted. During the search, a clear crystalline substance was found on Williams' passenger seat area, consistent with an attempt to discard the substance. The substance tested positive for Methamphetamine. Williams was transported to the Magistrate's Office where he was charged with Felony Possession of Schedule II (Methamphetamine). His first appearance was on 01/29/24 before a District Court Judge.

This is the ninth felony investigation that Williams has been implicated in since January 2023.

Since January of 2023, Williams has been arrested on the following charges:

Jon Bradley Williams is currently under \$440,000 (total) in bonds and is no longer in custody.
